#### 2.2. "Work with us" - Job Application Form

# Purpose:

To assess and manage applications submitted for open positions at Raconteur.

#### **Processed data:**

- Name
- E-mail address
- Phone number

CV and any information contained therein

### Legal basis:

The data subject's voluntary consent (Article 6 (1) (a) GDPR).

#### Retention period:

Application data are stored for up to **6 months** after the recruitment process is closed, after which they are automatically deleted.

If Raconteur wishes to retain the applicant's data for future opportunities, it will request explicit, separate consent.

# 3. Data Security and Access

Access to personal data is restricted to authorized personnel of Raconteur only.

Raconteur does not share, sell, or transfer personal data to any third party.

The Company ensures the confidentiality, integrity, and availability of all personal data through appropriate **technical and organizational measures** that prevent unauthorized access, alteration, disclosure, or destruction.

# 4. Data Subject Rights

You have the following rights in connection with your personal data:

- Right of access: You may request confirmation of whether we process your personal data and obtain a copy thereof.
- **Right to rectification:** You may request correction or completion of inaccurate or incomplete data.
- Right to erasure ("right to be forgotten"): You may request deletion of your personal data where the processing is no longer necessary.
- **Right to restriction of processing:** You may request limitation of data processing under specific circumstances.
- Right to data portability: You may request to receive your data in a structured, commonly
  used format or to have it transmitted to another controller.
